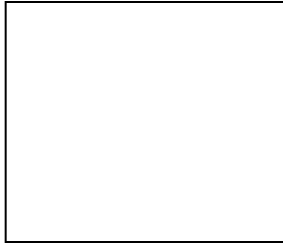
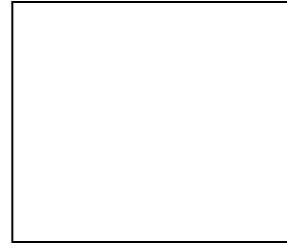

3. Birth Certificate/Voters Identity Card/School Leaving or Joining Certificate
4. Father's Residential Proof (in case of married women who has not submitted father's SSC/COI)
5. Indian Citizenship Certificate or Equivalent Document issued from Competent Authority (in case of foreign national women before marriage only)
6. Unmarried Certificate (in case of unmarried female applicant only)
7. Two passport size photographs
